This Agreement between Hawai'i State Tours (hereinafter HST), and the The Pride of Mayfield Wildcat Bands includes the following terms and conditions:

1) Hawai'i State Tours will provide the following:

- **Round-trip Air to Orlando, Florida (Parent/Family Tagalongs may/may not be on the same flight as their student(s). Staff/Chaperones will accompany all students on flights. In addition, we will be flying out/in to different airports in our general Cleveland vicinity).**
- **5 Days and 4 Nights in the Disney's All Star Resort**
- ****Disney Magic Music Days 4 Day Ticket Package – Includes Admission to:**
 - **Disney- Hollywood Studios**
 - **Magic Kingdom Park with Parade Performance**
 - **Epcot with "You're Instrumental" and "Auxiliaration" Music Workshop**

Below is a sample of the itinerary, which is subject to change. March 21st and 25th will be set in their respective parks. The parks/performances for March 22nd, 23rd, and 24th are interchangeable and thus, the final itinerary may reflect these changes from the sample itinerary below.

March 21 - Fly in early - then Hollywood Studios remainder of 1st day

March 22 - Epcot - with *You're Instrumental and Auxiliaration Student Clinics* (cost NOT included in price, however covered by Boosters)

March 23 - Universal - with a *MHS Jazz Ensemble Performance*

March 24 - Magic Kingdom - with *The Pride of Mayfield Wildcat Marching Band in Parade*

March 25 - Animal Kingdom Breakfast - Animal Kingdom - Fly Home

2) **Estimated Package Prices** are per person: Bottom number indicates total after 3% online payment convenience fee.

-These are Estimated Prices, so the final price may vary.

-ALL HS student participants will pay the Quad rate.

4) Making a payment. We will be using an online payment system for all payments. In December, everyone will be contacted, letting them know where to go online to start making payments. There is a convenience/transaction fee of 3%, like almost every online service. When making a payment, please make sure that your amount reflects the payments above, that TOTAL to Quad - \$1,199, Triple - \$1,269, Double - \$1,389, or Single - \$,1769. The convenience/transaction fee will be tacked on in addition to your payment dollar amount. The total for the January 15, 2016 Remaining Balance Due payment will be finalized shortly before that date.

5). Paperwork. Once you have met with your family and decided who is going, make your first payment by January 15, 2015 and immediately turn in your **Disney Participant Information** paperwork. This information is attached to this packet and is also available on the Band Website - ThePrideOfMayfield.org.

6). Rooming. Students will room together (room assignments won't happen until much later) and Tagalongs will group into rooms as they please. If any Tagalong(s) is interested in perhaps bringing down some of the cost by rooming with any other Tagalong(s), please contact Mr. Oshaben and he can put your parties in touch with one-another.

7). DISNEY and UNIVERSAL!!! Parents and students, please remember that the students will be chaperoned by our staff. Tagalongs, far as you are concerned, please consider this trip as a "vacation" for you and the rest of your family. Don't feel that you need to be a part of everything with your son(s) or daughter(s). Your son/daughter will be in parks supervised by chaperones and will be following student itinerary. There is no need to worry about your child as they will be in the care of Mayfield staff/chaperones

8). Participants in the trip will purchase the package as it exists. Tagalongs do have the option however to purchase Disney Parkhoppers & Universal Flex Tickets for additional \$249.00 if they wish. Additionally, though the schedule and trip package costs are firm, Tagalongs can choose to opt out on activities to do other/different things. With the exception of tagalongs being able to purchase passes or choosing to opt out on activities, there will be no other deviation from the itinerary.

- Students who wish to go on the trip will participate in everything that the trip offers, to the full extent of the itinerary. ALL STUDENTS WILL FOLLOW ALL SCHOOL AND TRIP RULES or consequences will be given.

9). January 15 is the deposit due date to reserve your place for this trip guaranteed at the trip price. After that date, signing up for the trip will be based on availability of flight seats reserved and subject to the current pricing rates on that date at which Hawai'i State Tours can secure seats.

10). Cancellation Policy: The cancellation policies outlines below takes into consideration the costs HST incurs long before groups ever depart. Notice of cancellation from the HST tour will be accepted from the participant, his or her legal guardian or the Group Leader. The date of cancellation will be determined by the date on which Hawai'i State Tours receives written notice.

HST Standard Cancellation Policy

- 120 day or more prior to departure - HST will retain 25 % of the Program Fee per person (minimum \$100 per person)*
- 119 days to 60 days prior to departure - HST will retain 50% of the Program Fee per person (minimum \$100 per person)*
- 59 days or less prior departure - No refund will be issued.

Cancellation with replacement

- 120 days or more prior departure - Full refund minus a \$150 per person substitution fee*
- 119 days to 60 days prior to departure - Refund minus a \$150 per person substitution fee plus any charges imposed by hotels and other suppliers imposed by airlines.*

Cancellation with replacement refers to a participant who cancels and finds a person to replace him or her for the same program. The replacement's enrollment form must be submitted at the same time as the notification of cancellation. HST cannot guarantee the replacement participant a place on the tour or the same flights as the group. This is primarily due to restrictions in airline agreements.

*Non-refundable fees are also deducted from refunds per person.
